I THEREFORE AGREE THAT I WILL ASSUME ALL OF THESE RISKS AND DO HEREBY, FOR MYSELF, MY HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS OF EACH, RELEASE AND FOREVER DISCHARGE KELLY VARNER AND COTTONWOOD CREEK RANCH, THEIR SUCCESSORS AND EMPLOYEES, FROM ANY AND ALL CLAIMS, DEMANDS, RIGHTS AND CAUSES OF ACTION OF WHATEVER KIND AND NATURE, ARISING FROM OR BY REASON OF ANY AND ALL INJURIES TO ME AND LOSSES OR DAMAGES TO MY PROPERTY THAT MAY BE SUSTAINED, AND FOR ANY MEDICAL EXPENSES SUSTAINED BY ME IN CONSEQUENCE OF ANY ACCIDENT, INJURY OR LOSS WHICH MAY OCCUR AS A RESULT OF MY ACTIVITIES AT OR FOR COTTONWOOD CREEK RANCH.**
